

RATES FOR OUT-OF-SCHOOL CARE 2019

As of the 1st of January 2019, Korein Kinderplein uses the following rates¹⁴. These rates do not take into account the benefits of the Dutch Tax and Customs Administration. The amount you ultimately pay is therefore lower than the monthly price as mentioned. The national standard¹ for out-of-school care is € 6,89.

IN ADDITION TO OUT-OF-SCHOOL CARE 2019

1. The national standard is the maximum hourly rate based on which the child care benefit from the Dutch Tax and Customs Administration is calculated.
2. The 12 weeks of school holidays include the following holidays: 1 week for autumn break, 2 weeks for the Christmas holidays, 1 week for spring break, 2 weeks for the May holidays, 6 weeks for summer vacation.
3. The opening hours of out-of-school care are in line with the school hours, the school weeks and school-free days of primary schools. The out-of-school care may consist of a short part of the day (Monday, Tuesday, Thursday or Friday), a long part of the day (on Wednesday or Friday) or a part of the day that connects to the school's continuous schedule. During the school holidays and school-free days of primary school, child care consists of a full day of 11.00 hours.
4. The 40-weeks package, excluding care during school holidays, is invoiced in 11 instalments. The monthly price and the number of hours a month will therefore not match the amount on the invoice.
5. Day care from 7:30. The children are taken to school by our staff. The number of hours of this product vary depending on the time that the school begins.
6. The availability of this service depends on the availability of the Korein Kinderplein.
7. The number of hours and/or the cost of this product vary depending on your personal requirements and school. Ask about the options that suit your particular situation.
8. You can request extra child care on your Korein Kinderplein.
9. At the 52- and 40-week packages, you choose one package for all the days that you use childcare.
10. The prices of these products include 9% VAT.
11. You pay for 49 weeks hot meal service instead of 52 weeks.
12. It is possible to make use of this product every other week. The availability of this service depends on the possibilities of the Korein Kinderplein. Even and odd weeks care is billed based on the actual calendar days per month.
13. You can make use of holiday care in full days (from 07:30 to 18:30) or in partial days. A morning lasts from 07:30 to 13:00 and an afternoon lasts from 13:00 to 18:30.
14. The monthly amount on your invoice can differ from the gross monthly rate stated on our pricelist by a maximum of € 0,10.
